President's Message

Success and Failure in the Legislature!

TBFAA had some successes and a notable failure in our legislative efforts this year. As you will read in the report on page 6 from Malcolm Reed, our Legislative Committee Chairperson, two bills passed that will improve how we are regulated by the Texas Commission on Private Security and the Texas Fire Marshals Office. The bill to close the loopholes concerning CCTV, access control and locksmithing is long overdue. And the legislation to allow local testing sites for fire alarm licenses is a big step for our industry.

But one set of bills, that would have made significant progress toward reducing false alarms in our state, failed because of a failure to communicate. The leadership of the Texas Police Chiefs Association opposed Senate Bill 1907 and House Bill 3236 which would have strengthened the TBFAA's efforts to reduce and eliminate false alarm dispatches in Texas. In spite of the fact that these bills were developed in consultation with, and with the support of, major municipalities in Texas and would have reinforced the capabilities of a municipality to recover 100% of the cost to respond to alarm calls, leaders of the Texas Police Chiefs Association opposed them, simply because they did not like the language that would have required law enforcement response to most alarm dispatches in the state of Texas.

Since learning of this opposition, I and others on our legislative committee have asked several local chiefs and local elected officials if they were opposed to the bills and so far all have expressed support. This led me to the realization that if we had possessed a way to communicate rapidly with all the chiefs and their local mayors and city councils we perhaps could have countered the formidable opposition of the Chiefs Association. So with the support of the TBFAA Board and our staff, we are now in the process of building a database of all local elected officials so that we will be ready for the next session.

As former Speaker of the House Tip O'Neil said it, "All politics is local". As members of our electronic security industry, we all need to do a better job of exercising our rights. I urge all of you to take some time to meet and educate your local and state elected officials about what you do, how many people you employ and how many fellow citizens you serve each and every day. Each contact you make will make our job representing your interests a little easier.

We owe a debt of thanks to many for their efforts in this years session. First it is impossible for any of us to repay Malcolm Reed, our Legislative Chair, for all the time, effort and expertise he has put forth. Our industry is a better one because of his efforts. His legislative team of JD Benfer, Kathleen Schraufnagel, Henry Homrighaus, Dennis Bryant, and Roger Byrd also extended an outstanding effort. Next we all owe special thanks to all the people who faxed and emailed in support of our efforts. The dedicated effort of Cliff Grumbles of TCPS and Mark Redlitz of the State Fire Marshals Office to answer all the questions on the implications of this legislation must also be acknowledged. I also need to acknowledge all the hard work by our lobbyist, Mr. Ron Kessler and his assistant, Ms. Carolyn Burton. Finally, I want to thank all the members of the Texas Legislature for their hard work and consideration of our issues, but I need to especially thank Senator Ken Armbrister, Representative Joe Pickett, Representative Joe Driver, Representative Todd Smith and their staffs for sponsoring legislation to improve public safety in the state of Texas.

Lots of hard work is done each day on your behalf by TBFAA. I urge you all to plan to Join us at the Sheraton BrookHollow on October 24, 25 & 26 for the 17th Annual Trade Show, Annual Meeting and Golf Classic to see what we are all about!

TBFAA Update

Legislative Update

The 78th regular session of the Texas Legislature has come to an end. We now await the Texas Governor's signature or veto of Senate Bill 1252 and House Bill 472, both of which will positively impact the Texas Electronic Security Industry.

Senate Bill 1252 by Senator Ken Armbrister and its house companion House Bill 2079 by Representative Joe Driver will make many changes to the Texas Commission on Private Security's regulatory authority. Specifically, it clarifies the definition of what an alarm company is and closes the access control and closed circuit television loopholes, which have existed for the last several years. The bill also creates a "D" class license for persons whom install access control systems, but not alarm systems. Additionally, the bill creates a registration process for persons engaging in the traditional locksmith business.

House Bill 472 by Representative Joe Pickett will allow the Texas Fire Marshal's Office to provide for testing services around the state rather than just in Austin. The testing fees will be slightly increased to cover the cost of the remote testing service, however, this service should make it very easy to get fire technicians and planners to a testing location without having to send them all the way to Austin, a cost savings for most.

The Texas Commission on Private Security will also see some changes soon. The legislatures reorganization of the state government currently has TCPS moving under the oversight of the Texas Department of Public Safety. Exactly what this will mean to Licensees is unknown at this time and may in fact be somewhat transparent. Keep in touch with TCPS at their web address of www.TCPS.State.TX.US for future details.

Senate Bill 1907 by Senator Ken Armbrister and House Bill 3236 by Representative Todd Smith consumed more time and energy of the TBFAA Legislative efforts by far than did any other issue during the 78th Texas Legislature. These bills would have strengthened the TBFAA's efforts to reduce and eliminate false alarm dispatches in Texas. The bills would have placed responsibilities on alarm consumers and alarm companies alike in the ongoing effort to reduce the time, effort and resources a municipality invests in alarm response, and would have reinforced the capabilities of a municipality to recover 100% of the cost to respond to these alarm calls. Unfortunately, members of the Texas Police Chiefs Association were successful in their extensive efforts to kill these bills, simply because they did not like the language that would have required law enforcement response to most alarm dispatches in the state of Texas. Both bills died in the final hours of the session because of the Texas Police Chiefs Association.

Many members of the TBFAA and its Legislative Committee again devoted thousands of hours of volunteer work this year. To them, we all owe appreciation for their time, energy and financial investment. The TBFAA's presence in Austin has never been as strong and mindful as it was during this past session. More importantly, every person whom makes his or her living in the Texas Electronic Security Industry owes a great debt of gratitude to several members of the Texas Legislature.

Senator Ken Armbrister has been an industry friend for many years and again this year he took the lead in the Texas Senate to promote excellent industry and consumer legislation. Senator Armbrister and his staff were more than cordial and went well beyond the call of duty when it came to working with TBFAA staff. Frankly, we hope we did not wear out our welcome! Without his support, our road would have been very difficult. Thanks Senator Armbrister and Staff.

Representative Joe Driver and his staff, especially Ms. Betty Horton, were instrumental in promoting industry legislation in the Texas House of Representatives.

Representative Driver and Ms. Horton worked tirelessly with TBFAA staff and the Texas locksmith industry to hammer out the differences in HB-2079. Without their determination and incalculable hours of work, HB-2079 and SB-1252 would not have seen the light of day. Representative Driver and Ms. Horton have worked with TBFAA staff for several sessions and we all owe a heartfelt and sincere "Thank You" to the both of them.

With the efforts of Mr. Mark Redlitz, Director of Licensing for the State Fire Marshal's Office, Representative Joe Pickett was able to draft HB-472 and nurse it through both legislative chambers. Each time we send a technician to a relatively close State Fire Marshal's Office testing facility in the future, let us all remember to whom we owe this appreciation. Even on the days when TBFAA staff experienced its worst defeats, Representative Pickett's staff and office setting always brought the smiles back and the optimistic outlook for the brighter tomorrow. Lets all now relax, kick back and enjoy an ice cold Coke while extending our gratitude for Representative Pickett's west Texas hospitality.

Thanks to all of the members of the 78th Texas Legislature who looked out for the Texas electronic security industry and its consumers, as well as all of the TBFAA members for their many trips to Austin and all of the good work. And lastly, the "Thank You's" would never be complete without expressing our sincere appreciation to Mr. Ron Kessler and his assistant Ms. Carolyn Burton, for their countless hours of hard work and determination in making this year a successful endeavor for the Texas Burglar & Fire Alarm Association.

Fact or Fiction?

Once upon a time there was a poor independent alarm dealer who had all kinds of bad luck. He was close to shutting his doors and going out of business. Putting his many trusted employees out of work bothered him as much as losing his company, because he cherished all of the years of hard work and dedication they had provided him and their company.

He searched desperately for reasons that brought this misfortune and disaster to his life's ambition and work, his company. He had prepared himself for this opportunity by working years for another company, studying business models, and saving for the eventual opportunity to own his own business. His devoted wife stayed up late at night with him finding additional ways to save money, she worked outside the home, saving her salary so that they could realize their dream, their own alarm company.

For the first time in their lives they were achieving their dreams. They worked hard, 70 to 80 hours a week and were driven to succeed by making effort. They pretty much stayed to themselves and were very concerned about competition. They watched all of their competitors and tried to figure out innovative ways to compete with them.

Then, slowly at first, things began to change, strange things were affecting their business. They began to have trouble competing and were losing sales. Some things seemed beyond their control. In several cities where they did business, they found that the city government was offering to monitor alarms, with preferential treatment to customers (like no false alarm fines), at a cheaper rate than they could afford. It didn't seem fair, but they were at a loss to do anything about it. They got a fax about the next local alarm association meeting and discussed it, but concluded that they were just too busy. They thought that it was just a bunch of competitors trying to learn about their business, but they were too smart to fall for that and, besides, they would want them to join and money was tight. The program speaker was to discuss pending legislation to address municipal monitoring.

Time went on and business got worse and worse. It seemed that locksmiths could now install CCTV and access control. They got another fax asking them to come to the next local alarm association meeting, but now money was really tight and, besides, who had the time? They were working harder than ever and it seemed losing money and market share.

They were at the end of the trail and were desperate to find any solution. They even considered selling their business and they didn't know where to turn. Just when they were at the end of their rope they got a notice from a customer saying that their city, Anytown, TX, had decided that the police department did not have to respond to alarms and that they would have to hire a separate guard service to respond before the police could be dispatched. This was the last straw and they decided they would tell their employees at the end of the week that they were going out of business. It was a bitter pill. The worst possible conclusion to the life's work of two dedicated, honest, committed individuals potentially affecting many and even their own relationship. The loss of prestige, creature comforts, and, most importantly, their dream, was devastating.

The next morning while suffering from no sleep and with an agonizing headache they noticed a fax on their machine and decided, out of desperation, to attend the local alarm association meeting; after all they would be needing jobs. What they discovered was a wonderful resource and mutual support. They met people with answers. They learned how their failure to get involved had almost cost them their business and how they could reverse some of their losses and solve many of their problems. They were introduced to individuals who could and would lend a helping hand. They became involved and, over the next two years, and with a lot of help they pulled through. They now realize that you can't ignore events and conditions that can effect your business and that the only way to protect yourself is by mutually banding with people of like circumstance to combat the negative outside influences that seek to effect all businesses.

Hey there are no fairy tales, only facts. Please heed the call and get involved, it is the only way to protect your business, your dream, and your company. If you aren't involved, you don't get the chance to participate. It's like voting, if you don't vote you have no say in your government. Don't let this be you. FBI Reports Small Drop in Crime Rates

Jun 19, 2003, WASHINGTON -- Overall violent crime decreased 1.4 percent last year in the United States, but the number of reported murder and rape crimes increased by 0.8 percent and 4.0 percent respectively, according to a preliminary FBI report made public June 16. The FBI's preliminary data for 2002 indicated a 0.2-percent decrease in the nation's Crime Index from the 2001 figure. The Crime Index is made up of numbers on seven offenses, including violent crimes and property crimes.

Among individual violent crimes, the number of robberies in 2002 decreased 1.2 percent from the 2001 total, and the number of aggravated assaults declined 2.0 percent. The overall property crime total remained the same compared with the 2001 total. Larceny-theft was the lone property crime showing a decrease, 0.7 percent, when compared to the previous year's total. Burglary increased 1.5 percent, and motor vehicle theft went up 1.2 percent. Arson offenses, included in the Modified Crime Index, decreased 3.7 percent.

The Northeast region reported a 3.3-percent decline in overall crime last year, the biggest decrease among all regions. The West was the only region to report an increase in overall crime -- 2.9 percent. Among different cities grouped by their populations, the data showed those with populations of 250,000 to 500,000 experienced the biggest decline, 1.9 percent, in their Crime Index. Those with populations of 50,000 to 100,000 saw the biggest increase, 1.2 percent. Overall crime had risen by 2.1 percent in 2001 compared with 2000.

Crime analysts suggested that the sagging economy could be the reason for the spike in suburban violence. But they cautioned that the spotty demographic and regional differences may simply indicate an adjustment in the usual cycle of crime that saw declines in all categories of major offenses during the past decade. The FBI report is based on numbers provided by police agencies across the country.

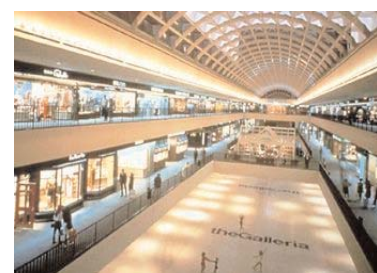

Please make sure all your Arlington customers are properly permitted.

Making a Good First Impression

In the world of sales, there are many factors that need to be taken into consideration to generate new prospects. Companies often get consumed with preparing marketing materials, or deciding which venue to utilize for their advertising. Many companies send their salespeople to training classes to hone their sales skills. But of all the things that companies do to generate sales, there is one important item that is most frequently overlooked: answering the phone.

The person who answers your company's phones has more of an impact on sales than almost any other person in your sales force. At our company, we refer to our phone receptionists as "Directors of First Impressions". We are very careful to make sure that they are polite and courteous with all callers. It just does not make sense for a company to spend huge sums of money on advertising, only to have their prospects run off by a less than courteous phone receptionist. After all, the way in which a company answers the prospect's phone call immediately sets the impression of that company in the caller's mind. There is an old saying that states, "You never get a second chance to make a good first impression". This is very true, and if a prospect is calling a list of businesses in the Yellow Pages, he or she will just move on to the next company if they do not like the way that the phone was answered. I would be willing to wager that just about everyone reading this article has done the same thing at one time or another; I know that I have.

It always seems that answering the phone is often put way down the list of priorities for companies. It is so insignificant for many companies that they forsake live courteous operators for automated attendants. Don't you just love those things! Press "1" to do this, press "2" to do that, press "3" to kiss your prospect goodbye! The general public may be acclimated to these things, but it doesn't mean that they like them. In my mind, there is just no substitute for the courteous, professional service provided by a friendly, live receptionist. This type of person will form a great impression of your company in the prospect's mind, and through their professionalism, they will also help your company retain your existing customers. How are your phones answered? Could you do better? Phone answering is so easily controlled, yet so often overlooked. Making the right impression on callers is paramount to generating new sales and retaining existing customers. To successfully grow your business, make sure that your company is creating a great first impression.
